The Group is managed by the Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Committee consists of 3 independent representatives, Chair, Treasurer and Secretary together with the Group Scout Leaders, individual section leaders and parent's representation and meets every 2 months.

This Group Executive Committee exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for:

The maintenance of Group property;

The raising of funds and the administration of Group finance;

The insurance of persons, property and equipment;

Group public occasions;

Assisting in the recruitment of leaders and other adult support;

Appointing any sub committees that may be required;

Appointing Group Administrators and Advisors other than those who are elected.

#### **Risk and Internal Control**

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighboring organizations such as the church, community centre and other Scout Groups. Similar reciprocal arrangements exist with these organizations. The Group has sufficient buildings and contents insurance in place to mitigate against

Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.

Reduced income from fund raising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.

Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.

Reduction or loss of members. The Group provides activities for all young people aged 6 to 18. If there was a reduction in membership in a particular section or the group as whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.

- The parent rota continues and Tara, Pete, Ruth, Paul, Alison, Ian, Curtise, Simon and Sarah have all regularly given time to the colony.
- THANK YOU to everyone for the excellent support for leaders.

I also want to thank Nikki, Kathryn and Sam who have helped me on various occasions throughout the year.

#### Activities during the year

- In April 2012 we challenged Beaver Scouts to be leaders for the evening by asking them to think of activities that they would plan and lead. Several took the challenge on George, Jack, Isaac, Luca, James, Alfie and Dylan lead games of basketball, dodgeball, Ninja, giants and wizards, and activities guess the Olympic sport, alphabet of countries, and sword making for St George's day.
- During the rest of the summer term 2012 the badges we completed were Safety Staged Activity, several walks for Hike Staged Activity Creative and Outdoor Challenges Experiment and Creative Activity.
- A new cycle of a two year plan began in September 2012 and badges worked on so far include Fitness, Creative and Global Challenges Imagination and Creative Activity. We have also been on several walks during the winter months for the Hike Staged Activity and James and Alfie are the first two people to be awarded their Hike 10 in Beaver Scouts! Other Staged Activity badges include Emergency First Aid 1 and in February 2013 half term 11 people took part in sessions held at Heeley Development Trust to gain their Information Technology 1 Staged Activity.
- From April 2012 March 2013 Alex, Romany, Asher, Alfie and James achieved the <u>Chief Scout Bronze Award</u>. This means they completed all six Challenge badges that require four activities for each challenge. Well done and thank you for your commitment during your time at Beaver Scouts!

#### **District Events**

- After the May District camp to Linnett Clough in May 2012 the District Beaver Scout Leader resigned. As another person hasn't been officially appointed the contact with BSL's in Sheaf has been limited and only recently a meeting held. Some suggestions were made for us to get together with other colonies in Sheaf which should be confirmed soon.
- In November 2012 the bi annual Beaver Scout Fun Day was held at Trippet Lane. Oak Street Beaver Scouts and family members attended to enjoy a morning or afternoon of craft activities.

#### The coming year ...

- This term we are working on Experiment and Healthy Eating Activity badges.
   Now the light nights are with us we will be getting out a lot more and doing several walks including one that will take place on the weekend that would normally be a District camp event.

We booked a day at Magna with the Education service and this was tailored to our needs. We made hot air balloons, big bubbles that we could stand in, made putty and went round Magna. The Cubs were great and we went on the bus there and back to add to the fun. Thanks to Kathryn and Fran for helping Dan, Lucy and I on a brilliant day.

Unfortunately due to the weather camps have been a bit thin on the ground this past year. We attended the District camp which the cubs really enjoyed, a bit of riffle shooting took place too which was great fun. The cubs always enjoy district camp and went on the Cube and all the other activities that were on offer to them.

We were due to attend the Synergise camp in July at Hesley Wood but this was put off due to the very wet weather that we had. This meant that the Cubs did not get to go on a summer camp.

#### Scout Leader's Report

What a fun-packed year we've had!

The year kicked off with the Hazlehurst Trophy, held in Ecclesall Woods. We entered two teams, 'The Men Who Stare at Goats' and 'R.J.H.H.' Meanwhile, Oak Street leaders ran a base, entitled 'sensory deprivation' where a scout, blind-folded and wearing ear-protection, was totally reliant on the instructions that came to them over the radio from their team mates. The scout had to navigate a course by following 150 metres of rope around trees and through a stream (twice), collecting foam balls as they went. This was popular and well run, thanks to all those who helped out. Our two teams were placed 6th and 10th overall and they had a brilliant time.

At the end of June, off we went to Rother Valley for Splashdown. Now, if the weather at Splashdown had been fine for a few hours that meant that sooner or later it was going to pour. When it stopped pouring we were wallowing in a thick layer of mud as the rainwater ran off into the lake. As usual, some of the scout's tents had the inevitable large pool of water inside, complete with a few sweet wrappers floating across the surface, surrounded by discarded drippingwet trainers and abandoned socks. Although we were subject to new stringent activity-related rules, Oak Street had a blast as usual. A special thanks goes out to those with the qualifications to run kayaking on the water - thank you for your extra effort and dedication! Thanks also to Phil I-O for running the kitchen and keeping us fed.

We built two rafts this year: one massive over-complicated contraption with padded seats and a keel, piloted by four lads, and another more basic one with four barrels and two planks, captained by Rhiannon. Rhiannon's team won the 'best construction' and the lads were 2nd in the raft race! Well done all involved. After, a few new scouts were invested out on the water. Later, our mess tent seemed to be the most popular venue after-hours, with about thirty-odd older scouting persons from various groups enjoying the atmosphere and company into the early hours; long may this continue.

Throughout the spring and summer, leaders pulled together to get Oak Street a climbing qualification so that the troop may nip out to the Peak District, with our own climbing gear, a lot more frequently. Many trips out to Stanage were made be leaders after their normal working day in order to gain the qualification. Thank you to all the leaders (and volunteer scouts) who gave up their time. We still have work to do in this area, but come the warmer, longer evenings, Oak Street scouts will be able to get out climbing frequently in

A major step forward for my vision of Oak Street as a climbing scout group was the grant of £1,800 funding secured by Exec Funding Officer Lucy Melleney. This money was spent on several climbing ropes, abseil ropes, gear, eight harnesses and eight helmets. Some of the money also paid for two sessions at the Foundry later in the year. We shall use the climbing equipment for many years to come.

After Splashdown came the big summer camp: SURFcamp. After investing some new scouts in mid-air at indoor skydiving establishment Airkix, Manchester, (thanks for the idea Sam!) we took two buses all the way down to Winkleigh, Devon, to camp in a field. You might say it was in the middle-of-nowhere. I'd say it was further away than that. Why do we always seem to set up summer camp in the dark and in the rain?

Numerous activities ensued, such as surfing at Westward Ho!, swimming at Saunton Sands, air rifle shooting at 1st Chulmleigh's hut, being rained off climbing in Cornwall, trapsing round soaking wet at St. Ives, a massive BBQ meal and a wicked seaside-themed fancy dress party, complete with outdoor sound system, heated swimming pool and fireworks finale. The weather for the majority of the time was either pouring wet, torrential rain, constant drizzle or prolonged heavy showers. A lot of scouts had very, very wet tents and clothes. I'll never go on another camp without wellies again. Many other things I think we'll never forget on that trip include: a fire engine that pulled up behind us as we sat on the motorway hardshoulder whilst a certain scout showed us his recent McDonalds, trips to the doctors, a midnight trip to A+E (only two broken wrists this camp) and the highly questionable fancy dress at

The camps in 2012 were coming thick and fast - a month after SURFcamp we went on Survival Camp. Three teams of scouts had to make their own shelters using nothing but branches, sisal and ferns. Some shelters were pretty good; some were less good. Which is a nice way of saying 'rubbish'. The Oak Street scouts who took it seriously learnt a lot from the other scout troops, whose constructions were ambitious and impressive. Most of our scouts simply lived up to the Oak Street ethos: shrug shoulders and say 'be rate'. Needless to say we didn't win any prizes for shelter design! We all had fun though. However, the shelters weren't as bad as some scouts ability to cook for themselves. Oh. Dear. Me.

Moving on, Steve ran a highly successful sequence of Angler's badge sessions in 2012. Scouts learnt angling theory and practical skills at the hut on Tuesday nights before taking part in a superb day of fishing out at Bradley's Pond, Ridgeway. Our scouts absolutely loved the experience and are keen to go again. Big thanks to Steve and Co. for running the badge.

October saw the start of the Climber's badge. We attended the Foundry climbing centre three times. Scouts recorded their progression in terms of achievement, ability and route difficulty. Some scouts were naturals and flew up the routes. Some had to conquer their fears and did really well to get up a couple of routes. We hope to get out climbing more often and that all scouts continue to gain more confidence and experience outdoors.

The Woodseats Venture Unit Sleepover in November was epic! On the Saturday we went go-karting followed by swimming at the new-improved Barnsley Metrodome and then onto laserquest as well. All in one day! The next day we went for a good old-fashioned hike up Lose Hill where we invested some new scouts on the cold hilltop before descending (sliding) back down. We were happy, exhausted and going to be back on time for parents. Everything had gone really well. Steve decided he was having none of it, so he put petrol in one of the diesel minibuses to spice things up. Two full minibuses, one towing the other, all the way back from Bamford in the dark, scouts screaming in terror, amusement and mild peril - that's more like it! Go Team Oak Street!

January 2013 saw Oak Street enter a team into the annual Sheaf District Cooking competition. Oak Street came second in Jan 2012, but now they were a year older, with more experience - the stakes were high. I'm delighted to report - Oak Street WON! Our four chefs did us proud, and took home the Golden Ladel trophy. Well done!

Other activities this year have included the usual Halloween party, night-hikes, ready steady cook, pancake night, the Easter Egg hunt, numerous wide games and other tomfoolery. Back to business from February onwards though: the new badges we are currently working towards are the Pioneer's and Camp Cook badges. It is no coincidence that these badges address the two major skills lacking on Survival Camp! Over many nights of fire-lighting, wood collecting, cooking outdoors, budgeting for camp food and planning meals, scouts (as we go to press in May 2013) will very shortly be cooking breakfast for parents after a sleepover at the hut. Cooking will be on an open fire, and any kitchen duties will also take place outside in scouts' own camp kitchens constructions. Good luck parents.

In terms of numbers, the Scout section is as popular as ever: currently we have 31 scouts on the books. We have several who are due to move up to Explorers around August 2013, but there is an ever-growing list of cubs (and others) on our waiting list to immediately replace any losses. I fully intend to keep us at our capacity of 32 scouts (8 per patrol).

A leader's report is not complete without explicit thanks for all the hard work that the leaders put in. Over the last year, Oak Street scouts section has grown from stength to strength, not least because of the increasing level of tremendous adult support. We now regularly enjoy a total of up to six leaders attending Tuesday nights. A big official welcome to the scout section to Lucy Turner and Ben Shaw. It is fantastic to have you on board and may I express my thanks on behalf of Oak Street for your positive input, commitment and support. Huge thanks to Dan Rhodes and Louis Clay who give up their time even though studying at college and university, both experienced and mature beyond their years. Finally of course, to Steve, my right-hand man: Steve - never underestimate how much you do for the troop. You are the glue that holds everything together.

I hope and imagine that our scouts understand just how beneficial belonging to Oak Street is for their social development, as well as the amazing memories and friendships that result. It simply isn't possible without all those helpers, parents and scouting families who give up their spare time for the benefit of others. To those who fundraise by running Bonfire Night and Christmas Cracker, and those who take care of the finances and run the Exec, may I extend special thanks. Thank you all.
