#### **Risk and Internal Control**

The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:

Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighboring organizations such as the church, community centre and other Scout Groups. Similar reciprocal arrangements exist with these organizations. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.

Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.

Reduced income from fund raising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.

Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.

Reduction or loss of members. The Group provides activities for all young people aged 6 to 18. If there was a reduction in membership in a particular section or the group as whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.

#### Activities throughout the year

#### April – Jul 2018

We started back after Easter completing the Animal Friend badge, with a visit to Pets at Home. The animal theme continued with a Bat Walk around Millhouses park. The beavers were surprised to actually hear bats and see a tree creeper. The highlight of the term was kayaking

#### District Camp

This was the first camp where beavers were invited to camp for the same amount of nights as cubs and scouts. 9 beavers camped for 3 nights and many came out for 2 nights. Children had to complete different super hero tasks and compete to be the winning team. As well as doing these tasks, children get involved in the running of camp, using axes and saws.

To celebrate all the years Denise had been with Oak Street Scouts, we held one final camp involving one of Denise's favourite activities, a walk. We caught the sardine train (yes it was that squashed) to Grindleford and walked to Hathersage, where we caught the train back to Sheffield. We camped at the hut. It was a lovely camp and very relaxed. It always sad to say goodbye to any member of the team but I wish her the all the best in the future. I have some very big shoes to fill.

#### Sept – Dec 2018

The new academic year starts with uncertainty, but then they come back to familiarity the scouting family. The badge we covered included Safety with visit from the British Transport police who taught us about safety on and around railway lines. Disability Awareness, experiment and Builder badge

#### Jan – Mar 2019

2019 started with our focus on re-introducing more traditional scouting values and incorporating the new philosophy of Skills for life.

We have done backwards cooking, knots, health and fitness, pancakes, torchlight walk, made tea light holders for Mother's Day, Planet pot led that session.

We have tried indoor archery after buying our own equipment and will take it outdoors soon.

The highlight of the term was taking 19 beavers to Legoland Discovery centre in Manchester. This involved train, bus, and walking. Followed by a sleepover at our hut. I had a fab adult support team, thank you Martyn, Ellen, Claudia, Laura and Dan for all your help on that weekend.

With Ellen stepping up to be Akela, I'm on the look-out for another regular helper. Laura has agreed to become a uniformed leader and I have Claudia, she's 18 next year. Ellen will continue to assist at Beavers but it is very tiring, doing 3 hours.

We welcomed Dan Howell to the section as an Assistant Cub Leader this and are still lucky to have Neil Foster and Millie Cassiday also as Assistant Leaders. From September my aim is to get Scouts involved in the section as young leaders.

#### Activities & Badges

We've had a year packed full of activities—from growing vegetables from seed, den building, kayaking and science experiments to making use of the groups new archery setup.

Back in November, Millie organised for the section to take part in Parliament Week where the Cubs learned about how UK politics works including parties, policies and voting. They created their own parties and policies and took part in a vote. Incredibly, Millie even managed to organise a visit from Magic Majid—the Lord Mayor of Sheffield at the time.

We've worked towards a variety of badges: Gardener, Emergency Aid, Nautical Skills, Scientist, Backwoods Cooking and many more.

Next year, we plan to continue developing traditional skills like fire building and cooking, map reading and pioneering; getting outdoors for walks, climbs and getting out on the water; and bringing in some new, more modern skills like programming. We're booked on to take part at Glenbrook in September where older Cubs will camp for the weekend and earn some of the more obscure badges like Photography and Chef and DIY.

#### **Camps & Sleepovers**

We began the year with a fun-packed sleepover at the hut back in November. We had a movie night, went ice skating, swimming and to Jump Incflatable at Parkgate.

The Cubs also had great fun at this year's group camp at Walesby where they took part in all kinds of activities like laser tag, zip lining, kayaking and bodyboarding. They were split up into teams with the Scouts and, although we didn't win the overall competition, 74th absolutely smashed the Quidditch tournament!

Next year we plan to fit in one more camp or sleepover (perhaps around March time ) as well as sending some of the older Cubs to the Freezer Camp at Hesley.
